CAMP REGULATIONS

1. Reservations are to be filed at Council Service Center at least 10 days in advance of trip. Permission to use site available only by permit. Unit must be currently registered (not lapsed or dropped) to use camp facilities.
2. Unit must be under Registered adult leadership, 21 years of age or older, at all times. A second adult (18 or older) is required in camp by National Council policy.
3. **Check-in:** campsite will be assigned by camp Ranger upon arrival. Camp fee payable on arrival at camp.
4. **Fires:** All fires must conform to local regulations and be built in designated spots for cooking or campfires. At no time leave any fire unattended. All fires must be completely extinguished before leaving. Leader will have signed Firestone Scout Reservation Fire Permit in his/her possession.
5. Campsites are provided with water and latrine facilities. (Large groups are required to provide additional toilets)
6. **Garbage:** You will need to take all your garbage home with you.
7. **First Aid:** Be prepared to handle all minor cases in your unit area. Major first aid to be reported immediately to camp ranger
8. Camp Cleanliness: Each unit is held responsible for the area in and around its assigned site, as well as the personal cleanliness of unit members.
9. **NO PETS IN CAMP.**
10. Stay within boundaries: Scouts to remain within camp property. Ranger should be notified if individuals or unit is hiking out of the main camp area. This is necessary in case of fire or other emergencies due to the fire danger during the year. Hiking may not be allowed in backcountry.
11. **Our Neighbors:** We enjoy good relations with our camp neighbors and ask units to observe Scout courtesy, not only to them but also to all persons while en route to and from camp.
12. **Transportation:** Transportation to and from camp is the responsibility of the sponsoring institution and the unit committee. All vehicles should conform to State of California highway regulations, should be driven by licensed operators 18 years of age or older, and have adequate insurance as required by the State of California. Under no circumstances are passengers to be carried in trucks (except in cab), or outside of vehicles.
13. **Check-out:** All units must clear through the camp Ranger prior to checking out at the close of their stay at camp.
14. **Damages:** In applying for this permit, the unit agrees to proper discipline of its members and will pay for damages caused by its members to the camp property.
15. **Absolutely No Alcoholic beverages allowed. No liquid-fueled stoves or lanterns allowed**
16. **Non-BSA groups must submit a certificate of Insurance to the Los Angeles Area Council with the reservation form in order to use the facility.**
17. **Non-BSA groups must also turn in a liability waiver form (one per individual) before entering camp. These forms can be obtained at the Council office in the camping department.**
